

INSTRUCTION SHEET FOR CERTIFICATE OF NATURALIZATION AN ALIEN PERSON

- **1.** Forms to be completed and signed by a Justice of the Peace or Notary Public.
- **2.** Reference letter from a reputable person in country of birth or residence and Grenada.
- **3.** Bank Statement to be submitted **after due diligence is completed** by this Ministry.
- **4.** Police Certificate of Character from country of origin and residence. **MUST** be dated within 6 months of application.
- **5.** Four passport size photographs **CERTIFIED** by a Justice of the Peace or Notary Public.
- **6. ORIGINAL** and **ONE (1) PHOTOCOPY** of Birth Certificate. If name does not appear on Birth Certificate, an **ORIGINAL** Affidavit is required.
- **7.** Letter stating date of arrival in Grenada, purpose of visit, the activities engages in and reason why applicant would like to be a citizen.
- **8.** Medical Certificate from **Registered Practitioner** which includes:
 - a) Chest X-Ray
 - **b)** Malaria Blood Smear
 - c) Serum Creatinine
 - **d)** RPR, VDRL or other serologic test for Syphilis
 - **e)** Stool for culture and Microscopic examination
 - **f)** HIV antibody test
 - g) Update immunization status including measles, mumps, rubella, tetanus and hepatitis B
 - * Immunization card <u>MUST</u> be produced. Copy of Immunization card.
 - **h)** Mantoux (TB) test

Persons traveling from high – risk areas or who have had recent malarial infection should be suitably treated with Promaguine.

(Medical Report to be submitted after due diligence is completed by this Ministry. The test <u>MUST</u> be conducted within <u>six (6) months</u> of the request by the Ministry to submit the Medical Report and <u>MUST</u> be done at the GENERAL HOSPITAL LABORATORY)

NB: Contact Number should be included on application.

9. Fee **EC\$7,500.00** plus **EC\$5.10** transaction fee to be made payable to "**Government of Grenada**" (*money order/Cashier's Cheque only*). Persons residing in Great Britain and Canada should make money order or Cashier's Cheque equivalent to **EC\$7,505.10**. Persons residing in the United States of America make money order or Cashier's Cheque for **US\$2,791.90**.
